India is the largest provider of generic drugs globally and is known for its affordable

Generic drugs, over-the-counter medications, bulk drugs, vaccines, contract research & manufacturing, biosimilars, and biologics are some of the major segments of the Indian pharma industry. India has highest number of pharmaceutical manufacturing acilities that comply with the US Food and Drug Administration (USFDA) and has 500 API producers that make for around 8% of the worldwide API market.

provider in 2022. Covid came as a huge challenge for the pharmaceutical industry. Identifying the disease and then developing medicine for it was the biggest challenge for

Indian and global pharma. The Indian pharmaceutical industry, however, took it as a challenge and developed vaccines that saved millions of lives. World leaders have already been impressed with Indian pharma and how it has the potential to reduce barriers to drug affordability and accessibility. The pharmaceutical industry was primarily focused on covid drugs in 2020, but by 2022, the focus had shifted to other severe diseases such as anemia and cancer.



A draft law to replace the 1940 Drugs and Cosmetics Act with a Drugs, Medical Devices and Cosmetics Bill 2022 was uploaded by the Union health ministry in early July, seeking public comments and objections, within 45

days. The primary objective of any drug law is to ensure that the medical products sold in a country are safe, effective and conform to prescribed quality standards. This article addresses how the new law could help consumers but what more is required. The first major feature in the new Bill that affects consumers relates to e-commerce. The regulatory cover will come when the rules are notified but the inclusion of a provision in the Bill is reassuring.

Panacea Biotec and Sanofi reached settlement agreement for Shan6



Panacea Biotec Limited and Sanofi Healthcare India Private Limited (Sanofi) have reached a settlement agreement for Shan6, a whole cell Pertussis based hexavalent vaccine (DTwP-HepB-Hib-IPV). Panacea Biotec Limited has instituted a

suit before Delhi High Court seeking to restrain Sanofi Healthcare India Private Limited from marketing a fully liquid hexavalent vaccine that would infringe the company's patent for its wP-IPV based fully liquid hexavalent vaccine, EasySix. The aforesaid suit was filed against Sanofi after Sanofi received marketing approval for a Shan6, a whole cell Pertussis based hexavalent vaccine (DTwP-HepB-Hib-IPV) by the Drugs Controller General (India).
